Definitions for Loansome Doc User Categories **Select ONLY One**

Alumni are graduates of The George Washington University School of Medicine and Health Sciences and the School of Public Health and Health Services. Himmelfarb Library encourages alumni who are no longer affiliated with The George Washington University to use the Document Delivery Services provided by their primary affiliation. As a courtesy to those alumni with no other affiliation, Himmelfarb Library will provide up to 3 articles per month at a significantly subsidized rate in support of their personal research and scholarship. Any alumnus who feels that their situation is unique, please contact library administration. Firms, organizations or corporations may not use the alumni status of an employee to obtain subsidized Interlibrary Loan or Document Delivery services.

Corporate Members have entered into an agreement with the Himmelfarb Library and paid a membership fee. The fee qualifies the Corporate Member for subsidized service rates and a library card which provides access during weekday non-public hours.

GWUMC Faculty are those persons who teach students at The George Washington University Medical Center. Faculty includes adjunct and George Washington University Medical Center emeritus faculty positions. Information at subsidized rates is used to support teaching, patient care and personal research.

Residents and Fellows are individuals being trained through the Office of Graduate Medical Education. Information obtained at subsidized rates is used for the treatment of patients or for the individual's education or research.

Staff employed by **The George Washington University Medical Center** or **The George Washington University Hospital (UHS)** are entitled to the same subsidized rates as the Faculty and Residents.

A **Licensed Health Professional** is engaged in an independent clinical practice where the information requested is in support of direct patient care activities or personal scholarship and research. Licensure entitles the individual to subsidized rates. This includes licensed medical doctors, physician assistants, nurse practitioners, registered nurses, doctors of pharmacology, clinical psychologists, dentists and licensed social workers. Those holding certificates in allied health areas do not qualify. Firms, organizations or corporations may not use the alumni or licensed status of an employee to obtain subsidized Interlibrary Loan or Document Delivery services.

Being a **Registered Student** of The George Washington University Medical Center qualifies for subsidized Interlibrary Loan and Document Delivery rates when using that information to further their personal education or research. This subsidized rate does not apply when the student is working for a department, faculty member or agency outside The George Washington University.

Non-Affiliated User is any individual or group that does not qualify for one of the above defined categories.
