**Background**

Secondary Fields of Study have been established within the University to provide opportunities for formal inter-school study. Students must be enrolled in a degree program and must be in good standing to be eligible to take a Secondary Field of Study in another school. The Secondary Fields generally consist of 15-21 credits of prescribed courses, depending on the Field. Upon successful completion of all requirements, the title of Secondary Field of Study and the courses taken in support of the Field are entered on the student's transcript.

The School of Public Health and Health Services offers the Secondary Field of Study/Minor in Public Health. Through this secondary field/minor, students are introduced to a wide range of issues in areas of public health such as health epidemiology, health management, health policy, health behavior, environmental and occupational health, global health, and others. The Public Health Secondary Field of Study/Minor consists of at least 18 credits (9 credits of required public health courses, three credits of either PubH 102 or PubH 103, and six credits of public health elective courses). The secondary field/minor provides a strong foundation in public health in preparation for professional schools including: law school, medical school, physician assistant school, allied health professional school, public health and health services school. **Admissions Requirements: 2.8 cumulative GPA or above.**

The School of Public Health and Health Services offers a Secondary Field of Study in Exercise Science through the Department of Exercise Science. Through this secondary field, students are introduced to a wide range of issues in the area of exercise science, personal health and wellness, anatomy, physiology, and kinesiology. The Public Health and Health Services Specialty Field of Study in Exercise Science consists of 15 credit hours (six credit hours of required courses and nine credit hours of advisor approved electives). The Secondary Field provides a strong foundation in exercise science in preparation for professional schools including: medical school, physical therapy school, nursing school, physician assistant school, public health, and further graduate study. **Requirements: 2.25 cumulative GPA or above.**
